## PLANNED & DEFERRED GIFTS

Your gift, or bequest, may include property, securities, or cash. It may be a specific dollar amount, a percentage of the estate, or a remainder after other distributions have been made. Bequests are distributed at an estate's settlement, have no impact on your current assets, and are often fully deductible for estate tax purposes.

We also ask that you sign a Declaration of Intent. The Declaration of Intent is non-binding and creates no legal obligation to you or your estate.

Members of the Legacy Circle may remain anonymous; all information will be kept strictly confidential.
